M/s. Green Fresh Agro Products, Represented by its Proprietrix : Mrs. C. Kavitha availed loan facilities from Indian Bank, T. Nagar Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s. Green Fresh Agro Products, Represented by its Proprietrix : Mrs. C. Kavitha failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 18.09.2025 under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling M/s. Green Fresh Agro Products, Represented by its Proprietrix : Mrs. C. Kavitha liable to the Bank to pay the total amount due to the tune of Rs.1,69,30,745/- (One crore sixty nine lakhs thirty thousand seven hundred and forty five only) as on 17.09.2025 with further interest, costs, other charges and expenses thereon. M/s. Green Fresh Agro Products, Represented by its Proprietrix : Mrs. C. Kavitha failed to make payment despite Demand Notice dated 18.09.2025.

As M/s. Green Fresh Agro Products, Represented by its Proprietrix : Mrs. C. Kavitha failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 29.11.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The total amount due as on 03.03.2026 is Rs.1,79,86,808/- (Rupees One crore seventy nine lakhs eighty six thousand eight hundred and eight only) with further interest, costs, other charges and expenses thereon from 04.03.2026.
