M/s Tecsol Electronics Private Limited availed OCC and TL facility from Indian Bank, Ernakulam Branch, the repayment of which is secured by Mortgage of schedule



mentioned properties hereinafter referred to as "the Properties". M/s Tecsol Electronics Private Limited failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 06.05.2019 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon M/s Tecsol Electronics Private Limited, Borrower(s), Mr.Shinu Kottaram (Guarantor/Mortgagor), Mr.Shabeer Abdul Rahman (Guarantor) and Ms.Priyanka G (Guarantor) liable to the Bank to pay the amount due to the tune of **Rs.2,16,93,218.98 (Rupees Two Crore sixteen lakh ninety three thousand two hundred eighteen and ninety eight paise Only)** as on 30.04.2019 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 06.05.2019

As M/s Tecsol Electronics Private Limited failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 09.09.2019 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 04.03.2026 is **Rs.3,89,98,974.00 (Rupees Three Crore eighty nine lac ninety eight thousand nine hundred seventy four Only)** with further interest, costs, other charges and expenses thereon from 05.03.2026.
