- a. The property/ies will be sold in "As is where is", "As is what is" condition, including encumbrances if any. (There are no encumbrances to the knowledge of the Bank. For details of encumbrance, contact the undersigned before deposit of the Earnest Money Deposit (EMD) referred to in 7(e) below).
- b. The property/ies will be sold above the Reserve Price.
- c. The property can be inspected as mentioned above.
- d. The intending bidders shall deposit Earnest Money Deposit (EMD) of **Rs 3.19 Lacs** being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS /NEFT in the account details as mentioned in the said challan" on or before **23.03.2026 up to 5.00 PM.**
