M/s Fabtech Infrastructure availed the above mentioned loan facilities from Indian Bank, Ernakulam Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr Jaiby Kuriakose (Borrower/Guarantor/Partner/Mortgagor) liable to the Bank to pay the amount due to the tune of Rs.2,44,76,380/- (Rupees Two Crore Forty Four Lakhs Seventy Six Thousand Three Hundred and Eighty Only) as on 31.12.2019 with further interest, costs, other charges and expenses thereon. George, Mr. Eldho N I and Mr Jaiby Kuriakose failed to make payment despite Demand Notice dated 27.01.2020.

As **M/s Fabtech Infrastructure**, failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 11.02.2021 after complying with all legal formalities.
