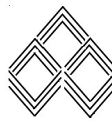

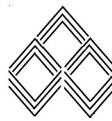
Whereas the borrowers & guarantors having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken possession of the secured assets more fully described in the schedule hereunder on **19.07.2023** under Section 13 (4) of the Act with the right to sell the same in **"As is where is"** , **"As is what is"** and **"Whatever there is"** basis under Section13(4) of the Act read with Rules 8 &9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as **Rs.93,41,645/39 (Rupees Ninety Three Lakhs Forty One Thousand Six Hundred Forty Five and Thirty Nine paise only)** for **141103707000014** & **Rs.26,34,645/57 (Rupees Twenty Six Lakhs Thirty Four Thousand Six Hundred Forty Five and Fifty Seven paise only)** for **141103453000004** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

After appropriating the repayments if any, the dues in the loan account as on **01.03.2026** is **Rs.72,57,100/- (Rupees Seventy Two Lakhs Fifty Seven Thousand One Hundred only)** for **141103707000014** and **Rs.33,38,612/- (Rupees Thirty Three Lakhs Thirty Eight Thousand Six Hundred and Twelve only)** for **141103453000004** along with further interest at contractual rates and rests, besides costs / charges incurred till the date of repayment in full.

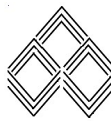
