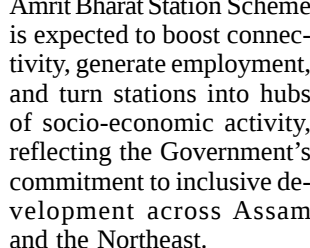


Police Operation Against Drug Traffickers in Tamarhat
