M/s Krishna Traders availed OCC facility from Indian Bank, Gwalior Main Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Krishna Traders failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 18.02.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) M/s Krishna Traders (Prop. Murli Manohar Parpyani) Bala Bai Ka Bazar, Lashkar ,Gwalior M.P.-474001, Mr. Murli Manohar Parpyani (Proprietor/Mortgagor) S/o Mr Nanak Ram Parpyani, C-14 Jai baba Bhawan Samadhiya Colony,Lashkar Gwalior (M.P.),& Mr. Shivam Parpyani (Guarantor) S/o Mr. Nanak Ram Parpyani Bala C-14, Jai Baba Bhawan Samadhiya Colony, Lashkar Gwalior(M.P) liable to the Bank to pay the amount due to the tune of 1,19,21,597/- (Rupees One Crore Nineteen Lakhs Twenty One Thousand Five Hundred Ninety Seven Only) as on 17.02.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 18.02.2025.

As M/s Krishna Traders failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 05.05.2025 after complying with all legal formalities.
