- 19) M/s Adish Product availed OCC and TL facilities from Indian Bank, Gwalior Main Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Adish Product failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 09.10.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) M/s Adish Products (Mrs Preeti Jain (Proprietor/Mortgagor) & Mr Vinesh Jain (Guarantor/Mortgagor) liable to the Bank to pay the amount due to the tune of Rs 95,14,738 /- (Rupees Ninety Five lakhs fourteen thousand seven hundred and thirty eight only) as on 08.10.2024 with further interest, costs, other charges and expenses thereon. As M/s Adish Product failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **21/06/2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
