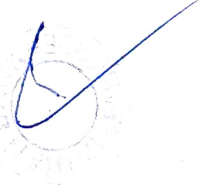

Mrs.Porchilambu W/o D.Rajinikanth Borrower & CO Borrower D.Rajinikanth S/o Devadass availed IBHL and IBHL plus facility from Indian Bank, Palacode Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mrs.Porchilambu W/o D.Rajinikanth Borrower & CO Borrower D.Rajinikanth S/o Devadass failed to pay the outstanding dues to the Bank. Therefore a **Demand Notice dated 06/10/2023** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s), Borrower / Mortgagors, Mrs.Porchilambu W/o D.Rajinikanth & CO Borrower D.Rajinikanth S/o Devadass, liable to the Bank to pay the amount due to the tune of **Rs. 55,91,613.00 (Rupees Fifty-Five Lakhs Ninety Thousand Six Hundred and Thirteen Only)** as on **11.02.2026** with further interest, costs, other charges and expenses thereon. They failed to make payment despite Demand Notice dated 06.10.2023.

As Borrower/Co-Borrowe (s), Guarantor(s), Mortgagors, Mrs.R.Porchilambu W/o Mr.Ranjinikanth, D.Rajinikanth S/o Devadass & Mr.K.G.Balakrishnan S/o Mr.Mr.Govindappan. failed to make payment despite



Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **12.02.2024** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 11.02.2026 is **Rs. 55,91,613.00 (Rupees Fifty-Five Lakhs Ninety Thousand Six Hundred and Thirteen Only)** with further interest, costs, other charges and expenses thereon from 11.02.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 20.03.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **17.03.2026 to 19.03.2026** between **10.00 am to 4.00 pm**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The sale is made on "As is where is and as is what is" basis and no representations and warranties are given by the Bank relating to encumbrance, Statutory liabilities etc.

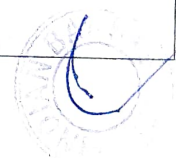
If the e-auction fails owing to any technical snag etc., the same may be re-scheduled by issuing 7 days' prior notice.
