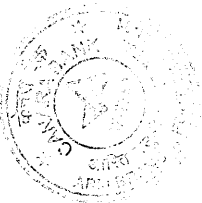

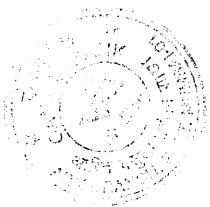

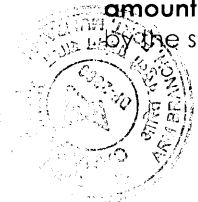

- a. The property/ies will be sold in "As is where is", "As is what is" condition, including encumbrances if any. (There are no encumbrances to the knowledge of the Bank. - b. The property/ies will be sold above the Reserve Price.

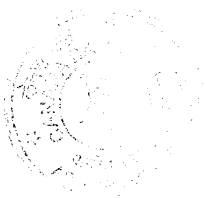
