TGSRTC ACCELERATES GREEN PUSH WITH ELECTRIC BUS RETROFIT PLAN

Hyderabad, Feb., 13: Taking a major step towards environmental protection, the Telangana State Road Transport Corporation (TGSRTC) is expanding its



electric mobility initiatives to reduce air pollution and promote sustainable public transport in Hyderabad. As part of its green strategy, TGSRTC has initiated a 'retrofitment' programme to convert old diesel buses into electric vehicles. Following the tenders issued in September 2025, the corporation awarded contracts for retrofitting 200 buses to Sai Green Mobility and 40 buses to Kalyani Power Train Limited. The corporation aims to deploy around 2,800 electric buses within the Hyderabad Outer Ring Road (ORR) limits by 2027, with officials expecting a significant reduction in pollution levels as commuters shift from private vehicles to public transport. Authorities also believe the initiative will help lower respiratory and heart-related health issues. Currently, 325 electric buses are operating across six depots, and another 175 are set to join the fleet this year. Charging infrastructure is being expanded, with facilities planned in 19 additional depots. Further plans include constructing 10 new depots and 10 charging centres at an estimated cost of Rs.392 crore. Notably, a diesel bus from the Musheerabad depot was successfully converted into an electric vehicle in 2023 and is currently operating within Uppal depot limits. TGSRTC Managing Director Y. Nagi Reddy appealed to the public to support the transition towards eco-friendly transport. Executive Directors Munishekhar, Venkanna, Rajasekhar, Vijayapushpa, representatives of Sai Green Mobility and Kalyani Power Train Limited and other company officials participated in the review meeting held at Bus Bhavan.

People back 'Praja Palana' governance in Municipal Polls: TPCC Chief Mahesh Goud

Hyderabad, Feb., 13: Telangana Pradesh Congress Committee (TPCC) President and MLC Mahesh Kumar Goud on Friday asserted that the Congress party's sweeping victory in the municipal elections reflects strong public endorsement of the State government's 'Praja Palana' (People's Governance) model. Talking to newsmen, the TPCC chief claimed that Congress secured a decisive mandate across Telangana, winning over 90 municipalities, four municipal corporations, more than 1,300 wards, and over 154 divisions. The results reaffirm people's trust in the party's governance and development agenda, he added. Goud attributed the victory to the leadership of Chief Minister A. Revanth Reddy and the government's focus on transparent administration, welfare schemes, social justice, women's empowerment, farmer support and employment initiatives for youth. Describing the outcome as a "renewed blessing" for the Congress government's long-term vision of 'Telangana Rising 2047', he said the mandate brings greater responsibility to accelerate development and deliver on public expectations. The TPCC chief criticised the opposition parties, accusing them of attempting to mislead voters



through misinformation campaigns, and said the electorate had chosen development over negative politics. Highlighting urban priorities, he said the government is implementing measures to strengthen infrastructure, including drinking water supply, roads, sanitation, and power facilities. Goud congratulated the party candidates, leaders, and grassroots workers for their role in securing the victory and reiterated the government's commitment to transparent, people-centric governance.

in the forest and rural areas, including Mallampet - Nakkalapalli (4.45 km) of Kotapally Mandal, Rajaram - Babberachiluka (2.14 km) in Kotapally mandal, Chinnaraspal - Vemanapally via Nagara, Lingala, Etapalli (7.127 km) in Vemanapally region, Racharla - Arjuvanagutta via Vemanapally, Algaon, Rooyalapalli, Sirsa, Annaram (10.604 km) of Vemanapally forest belt, Bopparam - Algaon (5.08 km), Kotapally mandal, Pandal - Kawar Kotapally (3.69 km) in Kotapally mandal.

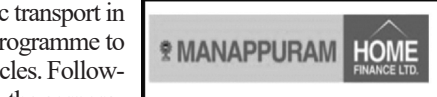
