Mr Sanjay Thakur and Mr Surendra Thakur has availed Housing Loan facility from Indian Bank, (Er.Allahabad Bank) Muzaffarpur Main Branch the repayment of which are secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr Sanjay Thakur and Mr Surendra Thakur** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice **dated 30.10.2025** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrowers **Mr Sanjay Thakur and Mr Surendra Thakur** and its Guarantors **Mr Rajiv Kumar Paswan and Mr Arun Kumar** are liable to the Bank to pay the amount due to the tune of **Rs.15,16,877/- (Rupees Fifteen Lakh Sixteen Thousand Eight Hundred Seventy Seven only)** as on **30.10.2025** with further interest, costs, other charges and expenses thereon from 30.10.2025 till realization of bank's dues. Both failed to make full payment despite Demand Notice **dated 30.10.2025**

As Mr Sanjay Thakur and Mr Surendra Thakur failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **05.01.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with
