BAANKNET, well before the auction date. The registration process takes minimum of two working days. (Registration process is detailed on the above website). - The Intending bidder should transfer his EMD amount by means of challan generated on his bidder account maintained with BAANKNET at https://baanknet.com by means of NEFT transfer from his bank account. 13. The bid submitted without the EMD shall be summarily rejected. The property shall not be sold below the reserve price.
14. The conditional bids may be treated as invalid. Please note that after submission of the bid/s, no correspondence regarding any change in the bid shall be entertained.
15. The EMD of the unsuccessful bidder will be refunded to their respective wallet maintained with M/s BAANKNET. The Bidder has to place a request with BAANKNET for refund of the same back to his bank account. 16. The Authorised Officer is not bound to accept the highest offer and the Authorised officer has absolute right to accept or reject any or all offer(s) or adjourn/postpone/cancel the auction without assigning any reason thereof. The sale is subject to confirmation by the secured creditor.
17. In case of forfeiture of the amount deposited by the defaulting bidder, he shall neither have claim on the property nor on any part of the sum for which it may be subsequently sold.
18. The successful bidder shall bear all the necessary expenses like applicable stamp duties / additional stamp duty / transfer charges, Registration expenses, fees, GST, etc. for transfer of the property in his/her name.
