US, ISRAEL ATTACK IRAN

PM ATTACKS CONGRESS

Donald Trump with the captions "PM is compromised". They also shouted slogans against the PM over the US trade deal as they held their T-shirts.

"Once Congress was the INC-the Indian National Congress. But today, it is no longer INC. Instead of INC, it has become MMC. MMC means Muslim League Maoist Congress," Modi said in his latest tirade against the party on Saturday, adding that Congress is "losing across the nation, and in anger, they are taking revenge by tarnishing India's image".

History bears witness that the Muslim League hated India, and that is why it partitioned the country, Modi said, further claiming that the Congress is doing the same. "Maoists too hate India's prosperity, our Constitution, and our successful democracy. They attack from ambush. Congress also sneaks in anywhere to defame the nation. The country will never forgive such misdeeds of Congress," he said.

The Prime Minister also alleged that its the Congress's "old habit" to defame the nation and weaken its armed forces. "Remember, this is the same Congress that left our soldiers longing even for weapons and uniforms. This is the same Congress that deprived military families of One Rank One Pension for years. This is the same Congress under whose rule massive scams took place in defence deals with foreign countries," he said.

In contrast, the armed forces have struck hard against terrorists and enemies over the last years, Modi said. "Our army has been victorious in every mission, every battle. From surgical strikes to Operation Sindoor, they proved their valour," he said. "Yet Congress leaders chose to amplify the lies of our enemies. Whatever is good for the nation, whatever benefits the people, Congress opposes it all. That is why today the country is teaching Congress a lesson."

Former Rajasthan chief minister and Congress leader Ashok Gehlot hit back, calling Modi's comments a "symbol of his political desperation". "For those belonging to an ideology that did not sacrifice even a fingernail in the freedom struggle to level allegations of dividing the country against the Congress, a party with a glorious history of leading the freedom struggle, is not only ridiculous but also proof of moral bankruptcy," he said in a statement.

Gehlot said the PM should not consider himself "bigger than the nation". "Modi ji, remember that opposing you is not opposing the nation. Do not make the mistake of considering yourself bigger than the country," he said.

As part of the HPV vaccination campaign launched in Kayad, Ajmer, several girls were administered the vaccine. The PM also interacted with the beneficiaries on the occasion.

According to officials, the campaign will cover girls aged 14 years. As per Registrar General of India 2021 estimates, the annual cohort of 14-year-old girls is around 12 million, who are expected to benefit from this initiative each year.

Officials familiar with the matter said a single-dose "Gar-dasil 4" vaccine, a quadrivalent HPV vaccine, will be used under the campaign. The injection provides protection against HPV types 16 and 18, which are responsible for cervical cancer, as well as types 6 and 11.

Modi also inaugurated and laid the foundation stone of projects worth around ₹17,000 crore in Ajmer. He also handed over appointment letters to more than 21,000 youths.

reported intercepting incoming Iranian missiles, with Abu Dhabi saying it "reserves its full right to respond" and slamming the attacks as "a dangerous escalation".

A bombing that targeted an Iraqi military base housing a pro-Iran group killed at least two fighters, sources from the powerful group Kataeb Hezbollah told AFP.

"We will soon begin attacking American bases in response to their aggression," the group said.

With the strikes underway, the exiled son of Iran's last shah voiced confidence in victory against the Islamic republic.

"We are very close to final victory. I want to be by your side as soon as possible so that together we can take back and rebuild Iran," Reza Pahlavi, who lives in the Washington area, said in an online video address.

Burj Khalifa evacuated after Iranian strikes

Dubai's Burj Khalifa, the world's tallest building, was evacuated after explosions were heard across the city as Iran launched retaliatory missile strikes targeting US military locations across the Gulf following joint American and Israeli attacks on Tehran, as per media reports.

Iran carried out attacks targeting locations in Abu Dhabi and Dubai in the United Arab Emirates, as well as Doha in Qatar and Riyadh in Saudi Arabia.

Residents in Dubai told AFP they heard loud explosions and saw missiles moving across the sky. "It was a big explosion, and it made the windows shake," one witness said.

A first wave of explosions had been reported earlier in the day, followed by more blasts later.

The UAE's ministry of defence said a civilian of Asian nationality was killed after missile debris fell in a residential area of Abu Dhabi.

"Such acts constitute a dangerous escalation and a cowardly act that threatens the safety of civilians and undermines stability," the ministry said in a statement.

Suspense continues ove newly-elected BJP national president Nitin Nabin, who the party insiders said would like to contest Lok Sabha polls from Patna rather than going to Rajya Sabha. "But the ultimate decision would be taken by senior leaders," said a leader.

Given the present arithmetic, the NDA could easily win four seats, while one seat could go to the opposition.
