Bareilly: A 32-year-old quick commerce delivery worker allegedly attempted self-immolation inside Baradari police station around 10.30pm on Tuesday after he failed to secure the release of his seized motorcycle, leaving him critically injured. Police said they are examining the circumstances leading to the incident.

Akshay Kashyap, a resident of Fatehganj Paschimi nagar panchayat who worked as a delivery agent and lived in rented accommodation near Kotwali in Bareilly, suffered severe burns on his abdomen, back, face and hands. Cops present at the station extinguished the flames and rushed him to the district hospital, where his condition remained critical.

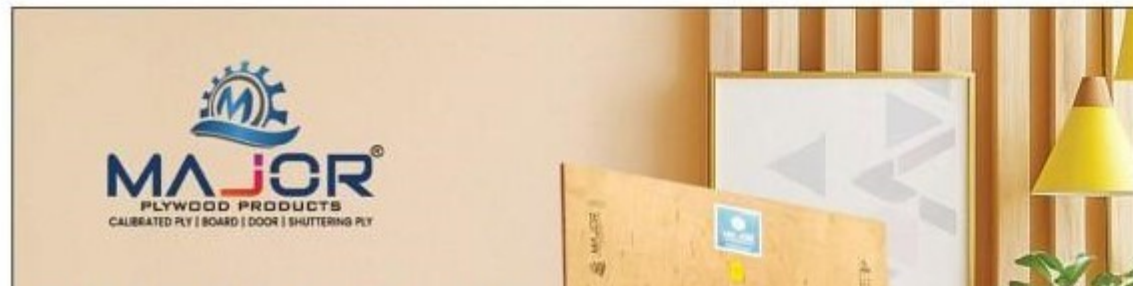
Talking to TOI from his hospital bed, Kashyap said, "I had gone to Gangapur Monday evening for a delivery and parked my motorcycle
