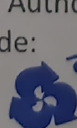

As Mr. Nafees S/o Natthoo (borrower) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 03.12.2025 after complying with all legal formalities.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended subsequent sale is required to be given and hence we are issuing this notice.
