Jharkhand's real GDP doubles; economic survey 2025-26 tabled in Assembly

Ranchi, Feb 21 (Representative)

The Economic Survey Report 2025-26 was presented on Saturday, with Finance Minister Radhakrishna Kishore highlighting significant growth in the state's economy over the past decade. Presenting the report, the minister stated that Jharkhand's real Gross State Domestic Product (GSDP) at constant

Added (GSVA) projected to reach Rs 1,37,730 crore in 2025-26 and Rs 1,48,479 crore in 2026-27, reflecting growth rates of 8.84 per cent and 7.81 per cent, respectively.

The report also noted that the state budget has grown more than 20-fold since the formation of Jharkhand, increasing from Rs 6,067 crore in 2001-02 to Rs 1,16,892 crore (actual) in 2024-25, with a budget estimate of Rs 1,45,400 crore for 2025-26. Total expenditure crossed the Rs 1 lakh crore

mark for the first time in 2023-24. The state has largely maintained fiscal discipline, keeping the fiscal deficit within the FRBM limit of 3 per cent of GSDP in most years, except in 2020-21 when it rose to 5 per cent due to the global pandemic. Banking infrastructure in the state expanded to 3,449 branches and 3,338 ATMs by September 2025, with 198 new branches added since December 2020. Between

March 2014 and September 2025, deposits increased by 220 per cent to Rs 3,79,735 crore, while advances grew by 124 per cent to Rs 1,58,714 crore. The survey further estimated that agriculture and allied activities would contribute around 12.3 per cent to Jharkhand's GSV in 2025-26, with overall agricultural GSV registering a 34 per cent increase to about Rs 28,470 crore. After the lunch break, the Assembly approved the Third Supplementary Budget for the financial year 2025-26 by voice vote, along with the related Appropriation Bill. Assembly Speaker Rabindranath Mahato adjourned the House proceedings till February 24 when the state government is due to present the Budget.



(2011-12) prices has doubled between 2011-12 and 2024-25, rising from Rs 1,50,918 crore to Rs 3,03,178 crore. He added that the state outperformed the national growth rate in four out of seven years between 2018-19 and 2024-25, while the economic contraction of 5.30 per cent during the pandemic year was less severe than the national decline of 5.8 per cent. The report projects the real GSDP to reach Rs 3,21,892 crore in 2025-26 and Rs 3,41,064 crore in 2026-27, indicating estimated growth rates of 6.17 per cent and 5.96 per cent, respectively. At current prices, the GSDP is expected to surpass Rs 5.6 lakh crore in 2025-26 and approach Rs 6.1 lakh crore in 2026-27. The Finance Minister informed the House that per capita income at current prices has crossed the Rs 1 lakh mark for the first time, reaching Rs 1,16,663 in 2024-25. Real per capita income has increased to Rs 68,357, marking a 65.7 per cent rise from the 2011-12 level, with an approximate CAGR of 4 per cent. According to the Economic Survey, the service sector is expected to witness sustained expansion, with Gross State Value

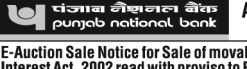
