M/s V J Threads availed the above mentioned loan facilities from Indian Bank, Ernakulam Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/s V J Threads** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 23.02.2021 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon 1. M/s V J Threads (Borrower) 2. Mr Varghese Joyce (Borrower/ Mortgagor) 3.Mr Sonu Poulose (Guarantor) liable to the Bank to pay the amount due to the tune of **Rs.1,40,40,387 (Rupees One Crore Forty lakhs forty thousand Three Hundred and Eighty Seven Only)** as on 21.02.2021 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 23.02.2021.



As **M/s V J Threads** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 05.08.2021 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 24.02.2026 is **Rs.2,74,24,776 (Rupees Two Crores Seventy Four Lakhs Twenty Four Thousand Seven Hundred and Seventy Six only.)** with further interest, costs, other charges and expenses thereon from 25.02.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.
