E-Auction Sale Notice

SALE OF IMMOVABLE PROPERTY MORTGAGED TO THE BANK UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT, 2002

Whereas, **M/S Malathi Fly ash Bricks Industry Rep by its Proprietor Sri Lingabathina Sessaiah S/O Vandanam R/o D No 2-179A, SC Colony, Rajupalem Lakshmipuram Village & Panchayat, Chimakurthy Mandal, Prakasam District, PIN-522226**, have borrowed monies from Indian Overseas Bank-Chandramouli Nagar Branch against the mortgage of the immovable properties more fully described in the schedule hereunder and upon classification of the account as NPA, the Bank has issued a **Demand Notice** to the Borrowers/mortgagers under Section 13(2) of the SARFAESI Act, 2002 (Act) on **17.03.2016** calling upon the borrower **M/S Malathi Fly ash Bricks Industry Rep by its Proprietor Sri Lingabathina Sessaiah S/O Vandanam** to pay the amount due to the bank, being, **Rs.16,97,531 (Rupees Sixteen Lakhs Ninety Seven Thousand Five Hundred and Thirty One Only)** as on **16.03.2016** payable plus undebited interest together with further interest, at contractual rates and rests along with costs and charges etc till date of repayment within **60** days from the date of receipt of the said notice.

Whereas the borrower/ Mortgagors having failed to pay the amount dues in full to the bank as called for in the said **Demand Notice**, the bank has taken **possession** of the secured assets more fully described in the schedule hereunder on **18.01.2021** under Section 13(4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under section 13(4) of the Act read with the rules 8 & 9 of the Security Interest (Enforcement) rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking **possession** was intimated as **Rs.32,15,589/- (Rupees Thirty-Two Lakhs Fifteen Thousand Five Hundred Eighty-Nine Only)** as on **17.01.2021** payable plus undebited interest together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on **24.02.2026** works out to **Rs.40,84,512.66 (Rupees Forty Lakhs Eighty-Four Thousand Five Hundred Twelve and Paise Sixty-Six Only)** plus undebited interest if any payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment, after reckoning repayments, if any, subsequent to the bank issuing the demand notice.

2. The intending Bidders /Purchasers are requested to register on portal <https://baanknet.com> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by **16.03.2026 before 2:00 P.M.** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.

3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/RTGS mode (**After generation of Challan from <https://baanknet.com> which will provide account details**) in bidders Global EMD Wallet account. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily.
