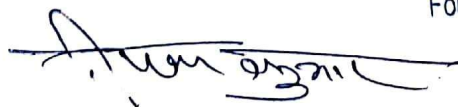

As **M/s New Maa Jagdamba Vastralay Prop. -Smt. Nisha Kumari W/o- Deepak Kumar** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 19.11.2022 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
