NOTICE OF SALE

Notice of sale under Rule 9(1) of The Security Interest (Enforcement) Rules 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Sub : Your loan account No.6638346725 of M/s.Vasavi Trading, Represented by its Sole Proprietor : Mr.P.B. Krishnaprasad with Indian Bank, Saidapet Branch (Erstwhile Indian Bank, Tamilnadu Open University Branch).

M/s.Vasavi Trading, Represented by its Sole Proprietor : Mr.P.B. Krishnaprasad availed loan facility from Indian Bank, Saidapet Branch (Erstwhile Indian Bank, Tamilnadu Open University Branch), the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/s.Vasavi Trading, Represented by its Sole Proprietor : Mr.P.B. Krishnaprasad** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **05.02.2019** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling **M/s.Vasavi Trading, Represented by its Sole Proprietor : Mr.P.B. Krishnaprasad and another** liable to the Bank to pay the amount due to the tune of **Rs.56,34,436/- (Rupees Fifty six lakhs thirty four thousand four hundred and thirty six only)** with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated **05.02.2019**.

As **M/s.Vasavi Trading, Represented by its Sole Proprietor : Mr.P.B. Krishnaprasad** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **28.08.2019** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **21.02.2026** is **Rs.1,59,26,238/- (Rupees One crore fifty nine lakhs twenty six thousand two hundred and thirty eight only)** with further interest, costs, other charges and expenses thereon from 22.02.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 16.03.2026 from 10.00 a.m. to 4.00 p.m. which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **12.03.2026 to 13.03.2026 between 10.00 am and 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.

The Tender/bid Form with the Terms and conditions can be had on-line from the website (<https://www.baanknet.com>) by using the provision in the system/software. The tender form and the terms and conditions would be available in the website from **02.03.2026 to 16.03.2026**.

Further, after completing their eKYC, the intending Bidders/Purchasers have to transfer the EMD amount in their e-Wallet before the e-Auction Date and time in the portal. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website (<https://www.baanknet.com>) **for depositing in bidders e-Wallet**.
