Sri Sashikanta Mallick and Mr Anil Mallick have availed the above mentioned facilities from Indian Bank, Puri Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Sri Sashikanta Mallick failed to pay the outstanding dues to the Bank. liable to the Bank to pay the amount due to the tune of **Rs.6,07,575.40 (Six Lakhs Seven thousand Five hundred Seventy Five and paisa Forty Only)**- as on **08.08.2023** with further interest, costs, other charges and expenses thereon. All of them failed to make payment despite Demand Notice dated **09.10.2023**.

As the borrowers failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **09.01.2024** (symbolic possession) after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, **30 days'** notice of intended sale is required to be given and hence we are issuing this notice.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, **30 days notice** for First time sale is required to be given and hence we are issuing this notice.

The amount due is of **Rs.6,07,575.40 (Six Lakhs Seven thousand Five hundred Seventy Five and paisa Forty Only)**- as on **08.08.2023** with further interest, costs, other charges and expenses thereon.

Please take note that this is notice of **30*** days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **30*** days.

The date of sale is fixed as 16.03.2026 which would be by e-auction mode.
