Sub: Loan account – M/s Maa Bhagwati Traders (A/c No- 50186789180) with Indian Bank Kanhauli Branch, Muzaffarpur

M/s Maa Bhagwati Traders Prop-Shiv Shankar Kumar availed Cash credit facility from Indian Bank, **Kanhauli** Branch the repayment of which are secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Maa Bhagwati Traders Prop-Shiv Shankar Kumar failed to pay the outstanding dues to the Bank. Therefore a Demand Notice **dated 19.06.2017** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) M/s Maa Bhagwati Traders Prop-Shiv Shankar Kumar and its Guarantors are liable to the Bank to pay the amount due to the tune of **Rs.20,53,918.36/- (Rupees Twenty Lakh Fifty Three Thousand Nine Hundred Eighteen Rupees and thirty Six Paise Only) as on 31.05.2017** with further interest, costs, other charges and expenses thereon from 31.05.2017 till realization of bank's dues.. Both failed to make full payment despite Demand Notice **dated 19.06.2017**.

As M/s Maa Bhagwati Traders Prop-Shiv Shankar Kumar failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 10.10.2017 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. \*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **25.02.2026 Rs.66,51,089/- (Rupees Sixty Six Lakhs Fifty One Thousand Eighty Nine Only)** with further interest, costs, other charges and expenses thereon from **25.02.2026**.

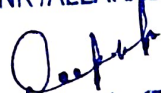
