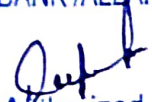

M/s Omega Educamp Pvt Ltd (Director- Prabhat Ranjan and Prashant Kundan) availed Cash credit facility from Indian Bank, Kanhauli Branch the repayment of which are secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Omega Educamp Pvt Ltd (Director- Prabhat Ranjan and Prashant Kundan) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice **dated 03.03.2020** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) M/s Omega Educamp Pvt Ltd (Director- Prabhat Ranjan and Prashant Kundan) and its Guarantors are liable to the Bank to pay the amount due to the tune of **Rs.68,53,660/- (Rupees Sixty eight Lakh Fifty Three Thousand Six Hundred Sixty Only)** as on **03.03.2020** with further interest, costs, other charges and expenses thereon from 03.03.2020 till realization of bank's dues.. Both failed to make full payment despite Demand Notice **dated 03.03.2020**.

As M/s Omega Educamp Pvt Ltd failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 02.12.2020 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

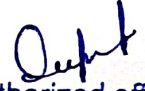
