Sub: Loan account – M/S UFSC HEALTHCARE (A/c no 50526465934 & 7112626612) with Indian Bank, Civil Lines Prayagraj Branch.

M/S UFSC HEALTHCARE availed **Loan** facility from **Indian Bank, Civil Lines Prayagraj Branch**, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/S UFSC HEALTHCARE** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **01.11.2023** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) / M/s UFSC Healthcare Guarantor(s) liable to the Bank to pay the amount due to the tune of **Rs. 48,69,630.00 (Rs Forty eight Lakh sixty nine thousand six hundred thirty only (as on 01/11/2023))** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated **01/11/2023**.

As **M/S UFSC HEALTHCARE** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **14.03.2024** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15day notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 29/10/2025 is Rs **.6312728.00 (Rs sixty three lacs twelve thousand seven hundred twenty eight only)** with further interest, costs, other charges and expenses thereon from 30/10/2025.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 16/03/2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from 01/03/2026 to 15/03/2026 between 10.00 am to 4.00 pm.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.

Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by 16/03/2026 i.e the e-Auction Date and before the e-auction end time in the portal. The registration and eKYC must be completed well in advance, before auction.
