

Health ATMs set for wider rollout across Telangana

THE State government plans to install rapid diagnostic testing machines, called Health ATMs, in hospitals with heavy outpatient load across the State. Officials said the initiative, tested on a pilot basis, showed positive results, expediting plans for wider rollout.

In August 2025, Health ATMs were launched at King Koti district hospital and Malakpet area hospital to strengthen diagnostic services in high-footfall government hospitals. Each unit can conduct 130 tests, including 65 non-invasive and 20 invasive (blood-based) tests, with results integrated into digital health records through cloud connectivity.

Officials said the machines are aimed at simplifying pre-consultation screening, reducing patient waiting time and improving diagnostic accuracy. To verify accuracy during the pilot phase, hospital staff collected blood samples from patients tested at the ATMs and sent them to T-Diagnostics, while some samples were also tested at private diagnostic centres.

Officials said the results matched, confirming the reliability of the machines. A report has been submitted to the government. The pilot was also ensuring continuity of care through digital records.

PM slams oppn over Sabarimala theft

Modi says Congress acting as a well-wisher for political gains & distanced from Hindu beliefs

GIVING an impetus to NDA's poll campaign in Kerala, Prime Minister Narendra Modi on Saturday tore into the LDF and UDF, accusing them of deliberately delaying justice and investigation into Sabarimala gold theft row.

Addressing a massive campaign rally in Tiruvalla, he said strict action would be taken against those responsible for the theft at the hill shrine if the NDA comes to power in Kerala. He further said the "days of the LDF government are numbered" in the State. In the second leg of his poll campaign in the State,



after his recent visit to Palakkad and Thrissur, Modi also took out a high-octane roadshow in Thiruvananthapuram, where thousands of supporters lined up the streets - waving flags - to catch a glimpse of the prime minister. In Tiruvalla, Modi began his speech

by offering prayers to Lord Ayyappa. Placing the Sabarimala gold theft issue at the centre of his attack on the LDF and UDF, he accused the two fronts of failing to protect the sanctity of the shrine. "Earlier, both the UDF and the LDF conspired to under-

mine the sanctity of the hill shrine. What began as attempts to dilute traditions has now escalated to allegations of theft within the sacred premises," he said.

He said there appears to be a pattern in these incidents. "When such issues arise during the LDF's tenure, the trail of accountability extends to elements linked to the UDF as well," he said, pointing to a "larger nexus between the two fronts". "That is why the LDF government is reluctant to seek a CBI probe. Congress, on other hand, has historically distanced itself from Hindu beliefs and customs, and is now merely 'acting' as a well-wisher for political gains," he said.

CM Stalin, Dharmendra spar over 3-language policy in CBSE schools

CHIEF Minister MK Stalin and Union Education Minister Dharmendra Pradhan locked horns on social media over the centre's proposal to introduce a three-language policy in CBSE schools starting from Class 6.

Stalin slammed the move as a "covert mechanism" to impose Hindi on non-Hindi speaking States, while Pradhan hit back, calling the CM's criticism a "tired attempt" to distract from political failures by mislabelling an inclusive reform. Citing a TNIE report, Stalin questioned the lack of "reciprocity" in the

proposal, asking whether students in Hindi-speaking States would be mandated to learn southern languages such as Tamil, Telugu, Kannada or Malayalam.

He further said the Union government had failed to make Tamil a mandatory language in Kendriya Vidyalaya schools and had not appointed adequate Tamil teachers.

Questioning whether the centre understood ground realities such as teacher availability, training capacity and infrastructure, Stalin described the policy as an ill-conceived move announced without proper planning, resources or accountability. He added that the priority should

be to equip students with skills in emerging sectors such as artificial intelligence and AVGC (Animation, Visual Effects, Gaming and Comics), while strengthening scientific temper and critical thinking. Imposing an additional language burden, he argued, could hinder students' progress.

Responding to the criticism, Pradhan dismissed Stalin's claims, calling the narrative of "imposition" a tired attempt to mask political failures. On reciprocity, he said Tamil had been celebrated as a national treasure through initiatives such as the Kashi Tamil Sangamam and on global platforms.
