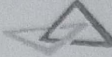

The intending bidders shall deposit Earnest Money Deposit (EMD) of Rs. 24,300/- being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" _____ on or before 16.04.2026 at 11.30 A.M. to 12.30 P.M.
5. Auction would commence at Reserve Price, as mentioned above.
