M/s Gomati Tel Mill availed Cash Credit and Term Loan facility from Indian Bank, Motihari Branch the repayment of which are secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Gomati Tel Mill failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 06.11.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) M/s Gomati Tel Mill and its Guarantors are liable to the Bank to pay the amount due to the tune of **Rs.16,40,332/- (Rupees Sixteen Lac Forty Thousand Three Hundred Thirty Two Only)** as on **06.11.2025** with further interest, costs, other charges and expenses thereon from 06.11.2025 till realization of bank's dues. Both failed to make full payment despite Demand Notice dated 06.11.2025.

As M/s Gomati Tel Mill failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **13.01.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **17.03.2026 Rs.16,43,043/- (Rupees Sixteen Lac Forty Three Thousand Forty Three only)** with further interest, costs, other charges and expenses thereon from **17.03.2026**.
