M/s Jai Bhawani Roller Flour Mill (A/c Nos. 7791632959, 7598822973 & 7603132397) availed Term Loan from Kathua branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Jai Bhawani Roller Flour Mill failed to pay the outstanding dues to the Bank. As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 06.04.2026 is Rs. **2,83,56,215.00 (Rupees Two Crore Eighty Three Lakh Fifty Six Thousand Two Hundred Fifteen only)** with further interest, costs, other charges and expenses thereon from **07.04.2026**.
