

CBI registers FIR in ₹550 crore IDFC bank embezzlement case

The CBI has registered an FIR in the alleged embezzlement of Rs 550 crore from the Haryana government's accounts maintained with IDFC First Bank in Chandigarh after taking over the investigation in the matter, official sources said Thursday.

The Haryana government had transferred the probe to the central probe agency. The referral was sent to the agency on Wednesday by the Department of Personnel and Training, they said.

The CBI registered the FIR taking over the case earlier probed by the Haryana State Vigilance and Anti-Corruption Bureau (SV & ACB).

"The case pertains to fraudulent banking operations and fictitious transactions allegedly undertaken in a systematic manner to siphon off Government funds into the accounts of shell entities, including Swastik Desh Project, SRR Planning Gurus Pvt. Ltd., Cap Co Fintech Services, R.S.Traders, and other associated firms/individuals, resulting in a substantial loss to the public exchequer," the vigilance department of Haryana said while referring the case to the agency.

According to the police and ED allegations, Haryana government funds were supposed to be deposited by various departments of the state in the bank in FDs but were allegedly diverted by the accused for their personal purpose, the sources said.

Failing typing test twice: Three Kanpur clerks demoted to peon posts

In a strict administrative action, the Kanpur district administration has demoted three junior clerks to Class IV posts after they failed to clear a mandatory typing test despite being given multiple opportunities.

District Magistrate Jitendra Pratap Singh ordered the demotion of Neha Srivastava, Amit Kumar Yadav and Premnath Yadav following a review of their performance. The three employees failed to achieve the minimum required typing speed of 25 words per minute in both the initial test and a second attempt conducted after a warning.

Officials said the employees had earlier failed the test in 2024 and were given another chance to meet the prescribed standard. However, their inability to qualify even in the second attempt led to the decision.

The three were appointed in 2023 under the compassionate grounds quota for dependents of deceased government employees and were posted as junior clerks at the Kanpur Collectorate.

According to officials, the action was taken to maintain administrative discipline and ensure efficiency in routine office work, including file noting, drafting and documentation, which require basic typing proficiency.

Kusmhi forest set to become eastern UP's eco-tourism hub

Uttar Pradesh is expanding its tourism footprint beyond religious destinations, with a renewed focus on eco and sustainable tourism. In a major step, an eco park is being developed in the Kusmhi forest area of Gorakhpur under a Rs 4.84 crore project, aimed at turning the region into a key green destination in Purvanchal.

Officials said Rs 50 lakh has already been released as the first instalment to fast-track work on the project, which is part of a broader plan to create nature-based tourism circuits and generate local employment.

Tourism and Culture Minister Jaiveer Singh said the initiative reflects the government's strategy to diversify tourism offerings in the state. He said that under the leadership of Chief Minister Yogi Adityanath, Uttar Pradesh is witnessing rapid expansion in the tourism sector, and Kusmhi forest is being developed as a modern eco-tourism destination with facilities such as Swiss cottages, tree houses, yoga centres and interpretation spaces.

The project is designed to strike a balance between visitor experience and ecological preservation. An entrance gateway is being constructed at a cost of Rs 15.58 lakh, while an interpretation centre worth Rs 28.45 lakh will provide insights into the forest's biodiversity and conservation practices. Swiss cottages, with an investment of over Rs 1 crore, are being developed to offer immersive stays in a natural setting.

Army rescues all 1,321 stranded tourists and 84 locals in Sikkim

The Indian Army has successfully evacuated all 1,321 stranded tourists and 84 local residents from North Sikkim on Thursday after landslides snapped road connectivity in the region, officials said.

Defence Spokesman Lieutenant Colonel Mahendra Rawat said that 'Operation Him Setu', launched earlier to evacuate stranded tourists in the Lachen area of North Sikkim, has been completed successfully. He noted that the evacuation of all stranded individuals was carried out in an incident-free, coordinated, and seamless manner within 48 hours, despite adverse weather conditions.

"A total of 1,321 tourists and 84 local residents were safely evacuated during 'Operation Him Setu'," the official said.

According to Lieutenant Colonel Rawat, connectivity in the affected area was restored through the construction of a footbridge, enabling safe and continuous evacuation across disrupted stretches following landslide damage on the Lachen-Chungthang road.
