Based on the victim's complaint, police have registered a case and launched an intensive manhunt. Senior officials have taken the incident seriously, assigning the investigation to an Additional Superintendent of Police. CCTV footage has helped in identifying the suspect, and special teams are actively searching for him, with some suspects already detained for questioning.

Chief Minister N. Chandrababu Naidu reacted strongly, directing police officials to ensure the immediate arrest of the accused and take strict action. He made it clear that crimes against women will not be tolerated under any circumstances and called for a firm response to send a strong message to society.

Officials informed the Chief Minister that swift action was taken upon receiving the complaint, including medical assistance and deployment of special teams.
