MISSING KIN, MENTAL STRESS: COPS PROBE MOTIVE FOR BREACH

NEW DELHI: A 37-year-old businessman Sarabjit Singh from Uttar Pradesh for attempted murder, criminal trespass, and obstructing public servants for allegedly breaching the Delhi Legislative Assembly in Civil Lines on Monday.

Police officials aware of the details of the investigation said it appeared that he had planned the breach and was suffering from a mental health crisis.

The incident took place around 2:10 pm when he used a white Tata Sierra with the registration 'UP26AZ8090' to break through the barricades to enter the premises.

Then, he got out of the car and placed a bouquet of flowers in the Speaker's unlocked vehicle before exiting the same way.

He intentionally used Gate No.2 to enter since it is closer to the Speaker's office, investigators cited above said.

A senior police officer, who asked not to be named, said, "It looks like Singh had planned this breach. He left his home and Pilibhit on April 1. He told his family he was going out for some work but has been missing for five days."

Singh hails from Pilibhit, UP, where he lives with his parents. His family owns a business.

Singh only called his family once between April 1 and 2, but, even then, didn't stay much. He then travelled to Bareilly on April 2 and stayed there for two days. "On Monday, he reached Delhi. His family has no idea about his whereabouts or his motive. They said he often suffers from fits of aggression," the officer added.

Singh was arrested around 4:15pm from the Roop Nagar. He was taken for questioning but has not revealed much and has been evading many questions, said police. He also allegedly told police he was looking for a lost relative.

Singh's family did not respond to HT's calls for comment.

Preliminary investigation by UP Police revealed that the Singh's nephew was a student residing in Delhi who had gone missing under suspicious circumstances last week. Police said Singh had travelled to Delhi to search for him.

Places flowers in Delhi Speaker's car

The entire incident was over in around 5 minutes with the accused getting away. He was later arrested from a police picket near Delhi University's north campus.

DRIVES TO SPEAKER'S CAR

As guards chase the vehicle, it is driven to the Speaker's car. There, a man, the sole occupant of the car opens the officials' unlocked vehicle and places a bouquet of artificial flowers and garland of marigolds in the boot.

EXITS THE SAME WAY

The man sits back in the car and drives out the way he came. As he flees, he nearly hits a rickshaw puller outside the gate.

MAN BREAKS THROUGH ENTRANCE

Around 2 pm, a speeding Tata Sierra speeds through the barricades of Gate No. 2 entrance, damaging the iron gate, and entered the premises.

ACCUSED TRACED TO N DELHI

Police then identify the accused as one Sarabjit Singh, using CCTV footage to trace him to Roop Nagar, where he is arrested at around 4-4.15 pm.

QUESTIONS OVER SECURITY

Calls were made to Delhi Police and other team around 2:15 pm. By then, Singh had already fled the scene without being caught. The incident raises questions about security at what is supposed to be one of the most secure locations in the national capital.

Man in SUV breaks through assembly security; held later

NEW DELHI: A man on Monday breached the Delhi Legislative Assembly, allegedly breaking through the barricades and damaging the iron gates to enter the premises, where he got out of the car and placed a bouquet of flowers in the car of Speaker Vijender Gupta before exiting the same way. The entire incident, which lasted around 5 minutes, raised questions over security preparations at one of the most secure locations in the national capital.

The man, later identified as Sarabjit Singh, a resident of Uttar Pradesh, was arrested at a police picket in Roop Nagar, near Delhi University's north campus, around two hours later. Police have yet to establish Singh's motive.

Confirming the incident, Gupta on Monday told HT, "I will aware the findings of the police investigation."

According to police officials, the incident took place around

2.10 pm when a speeding Tata Sierra, with a UP number, rammed through the barricades of Gate No. 2 of the Vidhan Sabha building. The gate, which is located near Vidhan Sabha Metro Station Gate number 1, is typically used by VIPs.

Security at the gate, which is manned by CRPF, is relatively lighter when the House is not in session and, on Monday, there were two guards on duty at this entrance.

The gate also leads directly to his office, where his car is usually parked, officials said.

As the guards were chasing the car, it stopped near the Speaker's unlocked car, said a police officer. Then Singh, the sole occupant of the car, briefly sat inside the Speaker's vehicle and placed a bouquet of artificial flowers as well as a garland of marigolds in the boot.

Within minutes, he got back in his car and drove out the way he came, nearly hitting a rickshaw puller right outside the gate. Police have recorded the statement of the rickshaw puller.

Gupta, who had gone to another part of the Assembly premises, "had entered his office minutes before the security breach," said another official.

Police identified Singh on the basis of his car's registration number. They scanned CCTVs nearby and traced him to north Delhi. Around 4:15 pm, Singh was arrested. "When we started checking CCTVs, we found that he was near DU North Campus and sent teams. He was then caught in Roop Nagar at a picket. We have also detained two others. They are also being questioned," said the senior officer quoted above.

Police said Singh, a resident of Pilibhit, UP, came to Delhi on Monday and the car was purchased around two months ago.

A third officer said, "We found that he had earlier supported farmers' protest in Delhi. He has also said he was searching for a nephew and came to Delhi on Sunday. He has no clear answers...As per local police's information, he is mentally unsound and came to Delhi to

look for his missing relative," said the officer. A taxi driver and another person have also apprehended. However, senior police officers said they have "no role" in the incident and were only with Singh at time of his arrest. Police said they may be released soon after questioning.

Security concerns

According to officials, around 50 police personnel are currently deployed on the premises across four gates. Security arrangements are strengthened during Assembly sessions. "Earlier, about 80 personnel used to be deployed, but the number has declined over the years. Gupta has one PSO (personal security officer) who accompanies him," an official added. A senior police officer said Delhi Police and CRPF personnel are also deployed around the premises. Around 50 such personnel were deployed across the four gates.

The Opposition Aam Aadmi Party said the incident raises serious questions over security at the Assembly.

{ HIMACHAL PANCHAYAT POLL } Powers given to DCs to modify reservation roster stayed by HC

SHIMLA: In a significant setback to the government, the Himachal Pradesh high court (HC) has stayed the state government's decision to grant deputy commissioners (DCs) discretionary powers to modify the reservation roster in up to 5% of seats for the upcoming panchayat polls.

The high court further said any reservation roster made under the new regulations will have to be redrawn. It reiterated its directive to all DCs to finalise and implement the reservation rosters for the polls by April 7, without fail.

The detailed order is awaited.

The decision comes during hearing of a PIL filed at the high court.

Petitioner's advocate, Nand Lal, said, "The state government did not have the power to bring in the amendment. It was an arbitrary move by the government. Considering our plea the HC has not just stayed but also directed the state government to ensure all roster as per the law be implemented by April 7. The HC also clarified that the election should be held by May 31."

Meanwhile, the DCs of five districts in the state issued the reservation rosters for the panchayat elections, including

Kullu, Shimla, Mandi, Kangra, and Hamirpur, which in view of HC order may have to be withdrawn. Following the HC's latest orders, if any DC had reserved 5% of the seats using their discretionary powers under the new regulations, the reservation roster in such cases will have to be redrawn.

Panchayati raj minister, Anirudh Singh, said "We respect the judiciary and HC order will be implemented."

Meanwhile, the leader of Opposition Jai Ram Thakur hailed the high court's decision.
