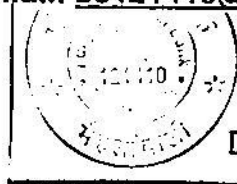

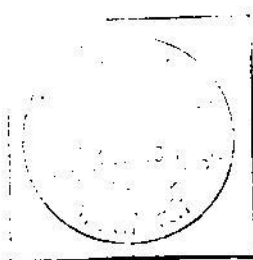
23. It is open to the Bank to appoint a representative and make self-bid and participate in the auction.

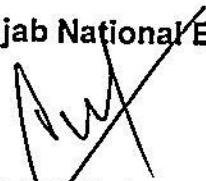
