Mr. S Tamilarasan & Mrs. C Selvarani availed Housing Loan facility from Indian Bank, Annamalai Nagar Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties **Mr. S Tamilarasan** failed to pay the outstanding dues to the Bank. Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), **Mr. S Tamilarasan & Mrs. C Selvarani**, liable to the Bank to pay the amount due to the tune of **Rs. Rs.3025204/- (Rupees Thirty lac Twenty Five Thousand Two Hundred and Four only)** as on 02.01.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 03.01.2025.

As Borrower(s), **Mr. S Tamilarasan & Mrs. C Selvarani**, failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **21.03.2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15-day notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 09.04.2026 is **3202720/- (Rupee Thirty Two lacs Two Thousand Seven Hundred and Twenty only)** with further interest, costs, other charges and expenses thereon from 10.04.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 29.04.2026 from 11.00 am to 4.00 pm which would be by e-auction mode.

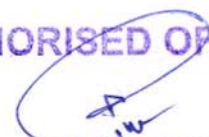
The sale is subject to confirmation by the Secured Creditor.
