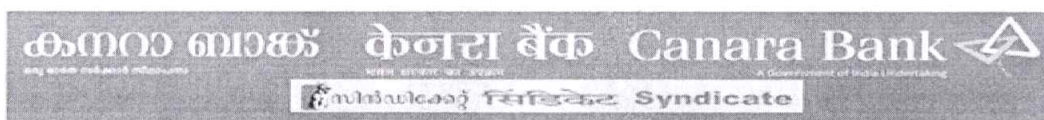

- b. The property/ies will be sold above the Reserve Price.

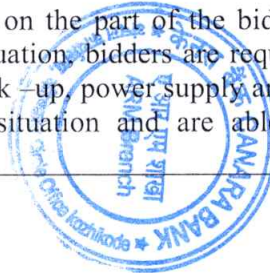
