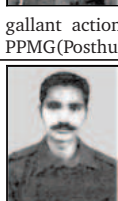

RG Kar hospital lift death: Homicide unit takes over probe; health dept seeks report from PWD

Kolkata, March 21

THE DETECTIVE department of the Kolkata Police's Homicide branch has taken over the investigation into the lift mishap death at the RG Kar Medical College and Hospital from the Tala Police Station on Friday evening.

The victim, Aroop Bando-padhyay, 41, died Friday morning after getting trapped in a lift of the trauma care unit of the hospital where he had gone for his minor son's surgery.

According to the police, they are investigating the absence of lift operators and security personnel at their designated duty spots at the time of the mishap. They have also collected CCTV footage of the area and the attendance register of the staff for the probe.

According to a senior official from the state health department, the lifts are maintained by the Public Works Department (PWD) under an annual maintenance contract. However, the PWD had, in turn, delegated the maintenance of lifts to private

companies. The engineers of the company responsible for the maintenance of the lift in question were summoned to the Tala Police Station for questioning.

According to sources, the lift had been installed in 2012 and was handed over to the hospital in 2013. However, there have been no reports of

any technical snag of late.

The official said that the health department has sought a report from the PWD on the condition of all lifts maintained by the department in state-run hospitals.

On Friday, the hospital authorities also announced that lifts will no longer operate without an operator. "Notices will be put up instructing people not to use lifts without an operator," said Saptarshi Chatterjee, Medical Superintendent, RG Kar Medical

College and Hospital.

Till now, five people – lift operators Milan Kumar Das, Biswanath Das, and Manas Kumar Guha, and security personnel Ashrafal Rahaman and Subhadip Das – have been arrested and booked under Section 105(3/5) (culpable homicide not amounting to murder) of the Bharatiya Nyaya Sanhita in the case.

The West Bengal Association of Health Service Doctors has expressed condemnation over the incident.

"That a life was lost in such a gruesome and unimaginable manner within a premier state-run facility is not just a lapse—it is a disgrace to the medical fraternity and a stinging indictment of the current administrative priorities. This incident is the tragic culmination of systemic negligence that we have repeatedly brought to the notice of the department of Health and Despite frequent reports of mechanical faults, the lifts in the Trauma Care Building remained death traps," it said.

"We demand non-negotiable action to ensure justice. We demand a transparent probe under the aegis of a sitting Judge of the Departmental enquiries often result in the shielding of high-ranking officials. The probe must identify administrative lapses starting from Secretariat and Directorate at Swasthya Bhawan down to the local hospital administration," it added.
