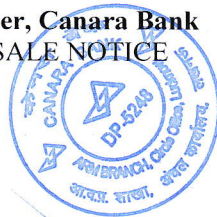
The undersigned proposes to sell the assets more fully described in the Schedule of Sale Notice.

- b. The property/ies will be sold above the Reserve Price.

- d.
