Vaishali Bhagat Goyekar (Borrower/Mortgagor) And Others availed Home loan facility from Indian Bank, vadgaon Budruk Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Vaishali Bhagat Goyekar (Borrower/Mortgagor)** And Others failed to pay the outstanding dues to the Bank. As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. 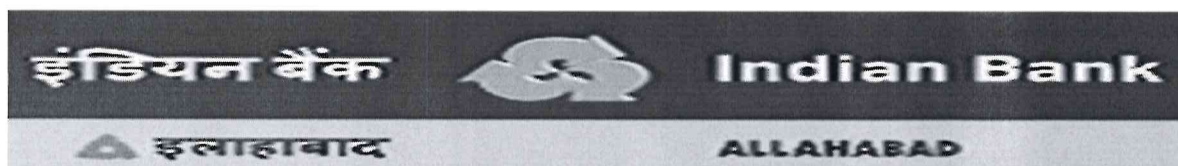
