Sri.Challa Sri Rama Chandramurthy(Borrower),S/o.ChallaNarasimha Murthy, and Smt.Challa Soma Sita Veeralakshmi, (Co-Borrower),W/o.Challa Sri Rama Chandra Murthy,have availed above said facilities from Indian Bank, Bhaskarnagar Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”.

Sri.Challa Sri Rama Chandramurthy (Borrower) and Smt.Challa Soma Sita Veeralakshmi (Co-Borrower) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated: 20.11.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) **Sri.Challa Sri Rama Chandramurthy (Borrower) and Smt.Challa Soma Sita Veeralakshmi (Co-Borrower)** liable to the Bank to pay the amount due to the tune of **Rs.26,38,423/- (Rupees Twenty Six Lakhs Thirty Eight Thousands Four Hundred and Twenty Three Only)** as on 19.11.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated : 20.11.2025.

As **Sri.Challa Sri Rama Chandramurthy (Borrower) and Smt.Challa Soma Sita Veeralakshmi (Co-Borrower)** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **06.03.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.



The amount due as on 23.03.2026 is **Rs.27,40,500/- (Rupees Twenty Seven Lakh Forty Thousand Five Hundred Only)** with further interest, costs, other charges and expenses thereon from 24.03.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 15.05.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **11.05.2026 to 14.05.2026 between 10.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule
