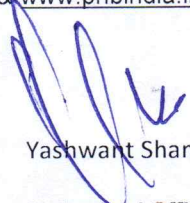

जागरण संवाददाता, मुजफ्फरपुर : दिल्ली के नजफगढ़ थाने की पुलिस ने मिठनपुरा थाने के मोहन सहनी टोला कन्हौली विष्णुदत्त में छापेमारी कर आरोपित शेखर कुमार को गिरफ्तार किया है। उस पर दिल्ली की किशोरी के अपहरण कर यौन शोषण का आरोप है। नजफगढ़ थाने की पुलिस ने उसे कोर्ट में प्रस्तुत कर 30 घंटे की ट्रांजिट रिमांड पर दिल्ली रवाना हो गई। पीड़िता की मां ने नजफगढ़ थाने में 17 जनवरी 2026 को प्राथमिकी कराई थी। इसमें कहा था वह 16 जनवरी को अपने साथ 15 वर्षीया पुत्री को लेकर स्कूल छोड़ने गई थी। दोपहर में वह उसे लेने गई तो पुत्री नहीं मिली। खोजबीन में पता नहीं चला। केस के जांच अधिकारी ने पीड़िता को ढूंढ़ निकाला। पीड़िता ने पुलिस को बताया कि आरोपित ने उसका अपहरण कर उसके साथ दुष्कर्म किया।

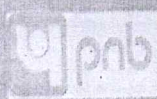

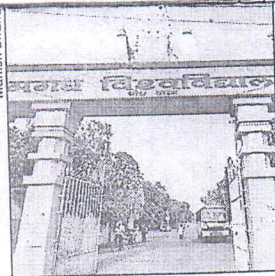

Gaya: More than 2,000 pensioners of Magadh University (MU) face the risk of suspension of pension payments as the university prepares to shift to the Samarth portal for academic, administrative and financial transactions.

The move towards a paperless system has exposed gaps in records, with key personal details, including Aadhaar number, Pan, mobile number, email address and marital status—unavailable for a large number of pensioners, many of them family pensioners.

MU registrar Binod Kumar Mangalam said the absence of details could disrupt payments. "More than 2,000 pensioners have not provided their personal details and as such in their case pension payment is likely to be suspended till they provide their details," he said.

He added treasury officials had earlier shown reluctance in clearing pension bills. "In the last pension payment itself treasury officials

als were reluctant to clear pension bills and the payment was made only after my personal intervention. Now the remaining pensioners will have to provide their personal details including Aadhaar number," Mangalam said.

Sources said MU has around 5,000 pensioners, of whom details of only about 3,000 have been uploaded, leaving nearly 2,000 without complete records.

The issue is compounded by the age of the institution. A number of pensioners retired before the introduction of Aadhaar, making

difficult. Many are now settled across the country, complicating efforts to contact them.

MU currently spends around Rs 35 crore per month on pension payments. It also continues to pay pensions to employees who retired before the creation of Veer Kunwar Singh University and Patliputra University, both carved out of MU. The state govt has been pushing universities to adopt the Samarth system for over a year and has made it clear that future salary and pension payments will be routed through the portal.

Kanhaiya Bahadur Sinha, president of the Federation of Association of University Teachers Association, urged caution. "The migration to Samarth for pensioners should be kept in abeyance till the university collects every detail of the recipients of pension. The problem is not MU specific as other universities too will be affected. Being an old university, MU will be affected more," he said.

Section 17A of the Prevention of Corruption Act provides that no investigation shall be conducted by a police officer if any offence alleged to have been committed by a public servant under the law without prior approval from the appropriate authority. Senior advocate Kapil Sibal, appearing for RJD leader, said that there should not be any investigation until the authorities get the sanction. "At least a final order

not be passed. Other matters are pending on the same issue and we don't get any relief. This is not fair," he said while the bench declined the relief.

The Delhi HC had on March 24 refused to quash CBI FIR in the case involving Yadav and his family members, rejecting the RJD chief's contention that the agency action was legally unsustainable in the absence of prior sanction under Section 17A.
