M/S Jyoti Gruh Udyog(Proprietor Mrs Jyoti Kirti Haria)availed MSME Loan from Indian Bank, Bhayandar 90 Feet Road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/S Jyoti Gruh Udyog(Proprietor Mrs Jyoti Kirti Haria) failed to pay the outstanding dues to the Bank. Mortgagor), Mr Kirti Visanji Haria (Gaurantor) liable to the Bank to pay the amount due to the tune of Rs.46,14,333/- (Rupees Forty Six Lakh Fourteen Thousand Three Hundred and Thirty Three only) as on 05.08.2025 with further interest, costs, other charges and expenses thereon. All of you failed to make payment despite Demand Notice dated 05.08.2025.

All of you have failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **06.11.2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, **15 days** notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **09.04.2026** is **Rs.52,59,103/- (Rupees Fifty Two Lakh Fifty Nine Thousand One Hundred Three only)** with further interest, costs, other charges and expenses thereon from **09.04.2026**.

Please take note that this is notice of **15 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **15 days**.

The date of sale is fixed as 29.04.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense on **27.04.2026** between 10.00 am to 4.00 pm.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

Further, they are requested to upload requisite KYC documents.
