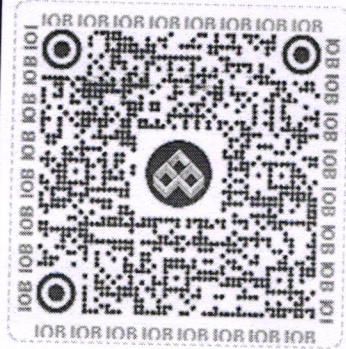
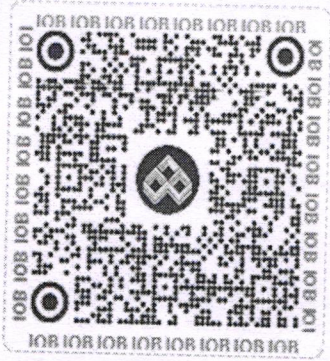

Whereas **Mrs. Sivagami V W/o. 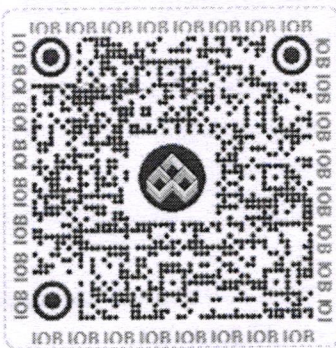
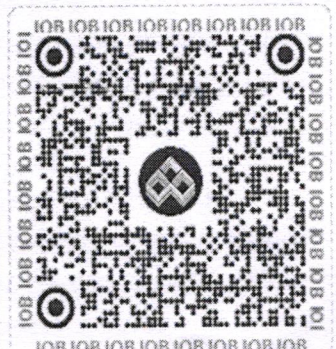
