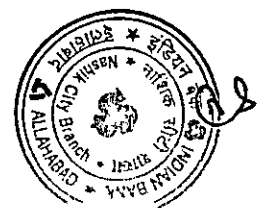

M/S JAI SHRIRAM FRUIT ICOMPANY prop. Virendra Prasad Bhagat and others availed loan facility from Indian Bank Nasik City Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/S JAI SHRIRAM FRUIT ICOMPANY prop. Virendra Prasad Bhagat and others failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 20.11.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon borrower(s), guarantor(s) M/S JAI SHRIRAM FRUIT ICOMPANY prop. Virendra Prasad Bhagat and



others liable to the Bank to pay the amount due to the tune of **Rs. 16,04,082 (Rupees Sixteen Lakhs four Thousand Eighty Two Only)** as on 20.11.2025 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 23.03.2026.

As M/S JAI SHRIRAM FRUIT ICOMPANY prop. Virendra Prasad Bhagat and others failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 16.02.2026 after complying with all legal formalities.
