of the subject Act in connection with outstanding dues payable by you to our Bank.

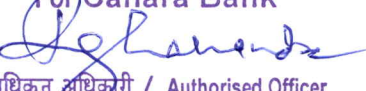

The intending bidders shall deposit Earnest Money Deposit (EMD) of Rs. **Rs.2,50,000/- (Rupees Two Lakhs Fifty Thousand only)** being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" on or before **17-05-2026** at 5:00 PM

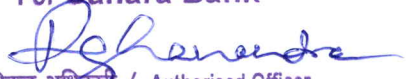
