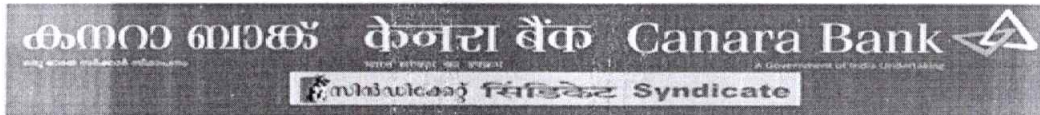
11. OTHER TERMS AND CONDITIONS
