M/s Reliable Construction availed credit facilities from Indian Bank (erstwhile Allahabad Bank), the repayment of which is secured by Mortgage of schedule mentioned property hereinafter referred to as "the Properties". M/s Reliable Construction failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 20.07.2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s) M/s Reliable Construction (Borrower), Proprietor- Shyam Sunder Vasishta, 2B/15, Russian Colony, Po-Kathara, Dist. Bokaro, PS Bokaro Thermal-829116, Jharkhand and also at 9, Dacres Lane, 1st Floor (upper), Room No.102, Kolkata-700069 and also at 1, Crooked Lane, 2nd Floor, Room no. 215, Kolkata-700069, Mr Shyam Sunder Vasistha (Proprietor/Guarantor/Mortgagor) 2B/15, Russian Colony, Po-Kathara, Dist. Bokaro, PS Bokaro Thermal-829116, Jharkhand and also at 9, Dacres Lane, 1st Floor (upper), Room No.102, Kolkata-700069 and also at 6B, Meghdoot, 12 Rowland Road, Po-Lala Lajpat Rai Sarani, Ps-Bhowanipore, Kolkata-700020, liable to the Bank to pay the amount due to the tune of Rs. 4,06,16,252. (Rupees Four crore six lakh sixteen thousand two hundred fifty two only)



as on 20.07.2022 with further interest, costs, other charges and expenses thereon. All of the above failed to make payment pursuant to Demand Notice dated 20.07.2022.

As M/s Reliable Construction failed to make payment despite Demand Notice, the Authorized Officer took **constructive possession** of the schedule mentioned properties under the Act on 17.11.2022 and took **physical possession** of the property on 28.02.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9 (1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of sale is required to be given and hence we are issuing this notice.

The amount due is **Rs. 4,06,16,252.00 (Rupees Four crore six lakh sixteen thousand two hundred fifty two only)** as on 20.07.2022 with further interest, costs, other charges and expenses thereon.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 15.05.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from 08.05.2026 to 11.05.2026 between 11.00 am to 4.00 pm.
