- b. The property/ies will be sold above the Reserve Price.
- c. The property can be inspected, with Prior Appointment with Authorized Officer, on any working day between 3 PM and 5.00 PM.
- d. The intending bidders shall deposit Earnest Money Deposit (EMD) of **Rs. 2,35,400.00 (Rupees Two Lakh Thirty Five Thousand Four Hundred Only)** being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" on or before **28.04.2026** at 5.00 PM.
