Mr. Atul Chandra Kant Chhatbar and Mrs. Hitiksha Atul Chhatbar availed Home Loan & Home Loan Plus from Indian Bank, Kandivali East Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Atul Chandra Kant Chhatbar and Mrs. Hitiksha Atul Chhatbar failed to pay the outstanding dues to the Bank.
