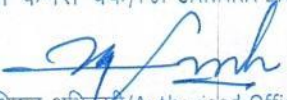
The undersigned proposes to sell the assets more fully described in the Schedule of Sale Notice.

- f) Auction would commence at Reserve Price, as mentioned above. 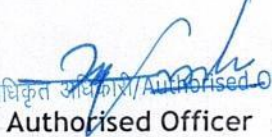
