12 (a) In case of bidding, the bid increment shall not be less than **Rs.30,000/-** in excess of highest bid amount or the immediate preceding bid, as the case may be with multiple increment value of **Rs.30,000/-**.

(b) Invariably, the first bid of the property/ies will be Reserve Price + one Increment. This amount will be the minimum bid amount to participate in bidding process.
